Anti-epidemic Measures

(Updated on 7 January 2022)

To fight against the COVID-19 and to safeguard the health of our service users, we require your co-operation in perusing and complying with the following anti-epidemic measures that being set in accordance with Prevention and Control of Disease (Requirements and Directions) (Business and Premises) Regulation (Cap. 599F):

1. The responsible applicant have to sign and return the ‘Group Health Declaration Form’ for his/her group upon check-in.
2. Anyone who has close contact with infectious disease, or arrived from overseas or visited Mainland China in the past 14 days before arrival, he/she is not permitted to enter into the Village.
3. During the check-in, our staff will remind the person-in-charge the measures of preventing Novel Coronavirus. All campers are required to take temperature.
4. All campers are required to wear a surgical mask in the premises of the Village.
5. All campers are required to maintain appropriate social distance with other people as far as possible.
6. During the stay, if member(s) of your organization is observed to have infectious symptoms, please immediately arrange the member(s) to seek medical advice from the nearest Accident and Emergency Department, inform our staff and fill in the ‘Notification of Infectious Symptoms of Novel Coronavirus’.
7. The maximum capacity allowed for all multi-purpose function venues is 50%.
8. ≤4 may be allowed in each guest room, and ≤8 persons may be allowed to stay in a suite.
9. All our camp quarters are in the zone of ‘Scheduled Premises’, campers MUST scan the “LeaveHomeSafe” (LHS) venue QR code once he/she enters the room of camp quarters.
10. Gymnasium and adventure facilities are temporarily closed.
11. All site programs are temporarily suspended.
12. Periodic sanitization has been carrying out for public facilities. °
13. Carpet sprayed with sanitizer was placed at our main entrance. Hand sanitizer is provided at various location in the Village.
14. Our Dining Hall adopts Type B Mode of Operation. The corresponding maximum number of persons allowed to be seated together at one table or one zone with effective partition is 4. The maximum capacity allowed is 50%, i.e. 80 persons.
15. Two-dishes with rice on individual plate or in box is served.
16. Dining Hall is closed at 6:00pm. Dinner is served either at 5:10pm at out Dining Hall or at 5:50pm with take away box.
17. All campers MUST complete the following steps before entering our Dining Hall:
 - i. scan the LHS venue QR. Specified categories of persons may fill in a specified form as an alternative;
 - ii. screen of body temperature; and
 - iii. sanitize hands.
18. Dining Hall provides serving chopsticks and serving spoons.
19. Cleansing will be carried out before and after use for all activity rooms.
